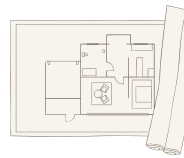

The expected cash inflows and outflows associated with the project over time.
-  **Return on investment**
The expected rate of return on the investment over time.
-  **Risk assessment**
The identification and analysis of potential risks that could impact the financial viability of the project.

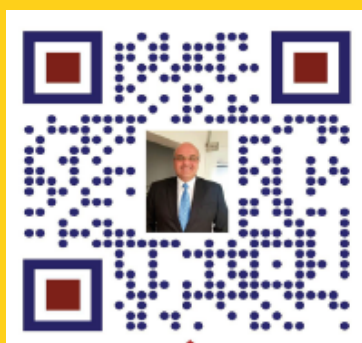
